### EXPLANATORY TEXT

The FIFA Laws of the Game shall apply except where specifically varied by these By-Laws.

*Text in italics is for commentary purposes only and does not form part of the By-Laws.*

### DEFINITIONS

*Within these By-Laws the following items shall have the meaning defined in this table.*

| <b>Average Points Per Game</b>  | Total competition points divided by total games played. Avg.  |

| <b>By-Laws</b>                  | These By-Laws of the Hills Football Limited including Schedules.  |
| <b>The Board</b>                | The Board of Directors of HFL.  |
| <b>Championship Competition</b> | Semi Finals, Finals and Grand Final Rounds after the Premiership Competition.   |
| <b>Constitution</b>             | The Constitution of Hills Football Limited.   |
| <b>Club</b>                     | A football club which is a member of or is otherwise affiliated with the Association.   |

### 1 ALTERATIONS TO THE BY-LAWS

*This By-Law defines who, how and when the By-Laws may be altered, amended or corrected.*

- 1.1 These By-Laws shall only be modified as per the Hills Football Limited Constitution.
- 1.2 Each member Club shall have the right to apply for variations or amendments of these By-Laws.
- 1.3 The BOD shall have the power to grant special case exemptions to the By-Laws.
- 1.4 These By-laws may be amended by the BOD if required due to A Force Majeure event.

### 2 TEAM NOMINATION, GRADING & REGISTRATION

*This By-Law defines how Clubs nominate teams to the Association, and how they are graded or allocated into competitions, and how team registrations are completed.*

- 2.1 Clubs entering team/s in the Associations' competition shall not be permitted to enter the same team/s in any other competition administered outside the Association without the permission of Hills Football.

#### 2.2 TEAM NOMINATIONS

- 2.2.1 Teams must be nominated by Clubs in the manner prescribed by the Board.
- 2.2.2 The closing date for the nomination of teams for the next season shall be fixed by the Board prior to registrations being open for each season.
- 2.2.3 Clubs shall submit information as requested by HFL with team nominations to enable Hills Football to facilitate suitable team grading.
- 2.2.4 By 5pm on the day prior to the date for team nominations, clubs must have their players who participate in HFL Competitions registered and assigned to their respective teams within Dribl.

- 2.2.5 For a team nomination to be accepted by HFL, a minimum number of players must be registered and assigned to the respective team within Dribl as defined:

| Team                 | Players  |
|----------------------|--|
| <b>11 v 11 teams</b> | must have 10 players registered and assigned to a team |
| <b>10 v 10 teams</b> | must have 9 players registered and assigned to a team  |
| <b>9 v 9 teams</b>   | must have 8 players registered and assigned to a team  |
| <b>7 v 7 teams</b>   | must have 6 players registered and assigned to a team  |

Once players have been registered and assigned to a team at the team nomination date, no more than 3 players per team can then be moved to another team unless this is discussed and approved by the HFL Competitions Manager.

- 2.2.6 Late nominations may be accepted at the discretion of the Competitions Committee.

### 2.3 TEAM GRADING

- 2.3.1 Following the closing date for nominations by Clubs for teams in each grade, the Competitions Committee shall meet and arrange suitable competitions for the season.
- 2.3.2 If insufficient entries are received in any grade, that competition may be suspended for the year and an alternative competition shall be recommended.
- 2.3.3 When there is a combination of two teams into one from the previous year then the highest division for grading for the current year for the nominated team will be no higher than the average of the previous year's two divisions unless nominated by the Club depending on the divisions available. Clubs submitting such nominations shall advise the names of at least four (4) players from the previous season's higher graded team.
- 2.3.4 Hills Football may regrade teams at the completion of the fourth Round played. This will be in line with the Competition Regrading Policy.
- 2.3.5 Grading will be based on prior years results as follows.
- 2.3.5.1 The highest placed premiership team in a division from the previous season will be promoted to the next highest division. Where there is no higher division, they will remain in the same division as the prior year.

- 2.3.5.2 The lowest placed premiership team in a division from the previous season will be relegated to the next lowest division. Where there is no lower division, they will remain in the same division as the prior year.
- 2.3.5.3 Where a club believes a team should be in a different division to those mentioned above, they shall be required to put this in writing to Hills Football with the team nomination.
- 2.3.5.4 The above clauses do not prevent Hills Football from grading teams differently to ensure correct balancing of competitions or where teams would be disadvantaged based on the above grading.

### 2.4 TEAM REGISTRATIONS

- 2.4.1 A team must consist of at least four (4) players for Under 6 to Under 7; six (6) players for Under 8 to Under 9; eight (8) players for Under 10 to Under 12; nine (9) players for U13 Girls; ten (10) players for Under 13 to Over 55; five (5) players for Walking Football; and fourteen (14) players for Premier League must be registered with the Association by the Team Nomination date and time advised by HFL.
- 2.4.2 Clubs with outstanding teams not registered must seek re-admission for these teams from Hills Football prior to the first competitive game. Any team re-admitted shall be subject to a late team fine, in accordance with By-Law 13.
- 2.4.3 Registration of additional players will then be accepted up until the day stipulated by By-Law 4.17.
- 2.4.4 The closing date for team registrations for the next season shall be fixed by the association following completion of the current season.
- 2.4.5 Late team registrations may be accepted at the discretion of the Competitions Committee.

### 3 TEAM COACH(S) AND MANAGERS

*This By-Law requires that all teams registered with the Association have a team coach and/or team manager registered with the Association to facilitate communication with teams. A player may be a coach or manager.*

- 3.1 Each team must have at least one (1) team official, who may be either a coach or manager, registered with the Association by the second competition game.
  - 3.1.1 Any team which does not have at least one team official registered by the due date of By Law 3.1 shall be fined the equivalent of a forfeit fee for each match until such time as By Law 3.1 is satisfied.

- 3.2 All registered team officials shall be issued an official Photo ID by the Association with the official's photograph.
- 3.2.1 A Team Official/s, including stand-in Team Official/s shall identify themselves/s as such to the Referee prior to kick-off.
- 3.3 The team officials shall be noted on the team sheet for all games in which they are acting in that capacity.
- 3.4 The BOD reserves the right to enforce any team to have a Team Marshall where they deem necessary.
- 3.4.1 Any person that works with or represents children (a person under the age of 18) within the Association shall be aware of and meet the criteria set down by the NSW State Government for Working with Children. Clubs shall be responsible for ensuring their Club is compliant with the NSW Working with Children requirements.
- 3.5 Hills Football and Member Clubs recognise the importance of Coaching and the positive influence that good coaching has on our youth players both for technical ability and for the enjoyment of football. Member Clubs are required to use all reasonable endeavours to ensure that their Coaches of division 1 youth teams have obtained an approved qualification commensurate with the age group and or age grade they are coaching.

Hills Football is committed to improving the development of youth players via appropriately accredited coaches and will provide coaching courses throughout each season and each pre-season open to all affiliated Member Club's so Member Clubs have every opportunity to upskill their coaches.

From season 2027, it will be a mandatory requirement that all division 1 coaches of U8 to U18 competition teams shall have a minimum of foundation of football accreditation, where an age grade between U8 to U18 does not have a division number specified, such as U8 to U11, the same requirement shall apply to the highest division within those age grades.

## 4 PLAYER REGISTRATION

*This By-Law requires that all players are registered with the Association. It also defines the eligibility criteria for playing in the various grade competitions and how players registered for one team may be re-registered with another team.*

- 4.1 Any person wishing to participate in the Association's Competition must be properly registered with the Association. No contracted players are permitted to register with the Association.

- 4.2 A player shall become a registered player with the Association once all of the following have taken place.
- 4.2.1 The player or parent/guardian must complete and sign a Play Football electronic registration form thus agreeing to abide by the rules and regulations of FA, FNSW, the Association and the Club.
  - 4.2.2 The player must pay the relevant registration fee.
  - 4.2.3 The Club must submit to the Association the player's registration and photo (as required) in the manner prescribed by the Board.
- 4.3 Every registered player playing in the under 10's and above shall be issued an official Photo ID by the Association with the player's photograph. Photographs shall be updated every three (3) years. For players above 21 years of age, photographs shall be updated every five (5) years unless the Club or Association considers a player has changed his/her appearance so as not to be easily recognised from the current photo.
- 4.3.1 All new players to the Association must provide a photograph.
- 4.4 Once a Club has submitted to the Association the required information to register a player by the prescribed cut-off date the Association will provide the club with electronic ID Cards. Electronic Photo IDs must be used at all matches as proof of registration for the player's club and team.
- 4.5 For the purposes of the "Accident Support Program", a player is considered registered with the Club from the time he/she completes the aforesaid electronic registration and may submit a claim to the insurance company upon the Club completing the player's registration with the Association.
- 4.6 To be eligible to play in "Under Age" Grades, a player must be under the relevant age on the 31st December of the previous year.
- 4.7 The highest-grade players under the age of 16 may register in is two grades above the age they will turn in a calendar year. A Club may apply to Hills Football in writing for permission for a player to play in a higher grade.
- 4.8 There is no upper age restriction once a player has turned 16 years of age however the association strongly encourages clubs and players to play in the grade relevant to their age.
- 4.9 In the U21 competitions, players must be under the age of 21 before the 31st of December of the previous calendar year and is recommended for players turning 19, 20 or 21. In the U18 competitions, players must be under the age of 18 before the 31st of December of the previous calendar year and is recommended for players turning 17 or 18.

To be eligible to play in the Over 30 Women's Competition, a player must have turned 30 before the 31st of December of the previous Calendar Year.

4.9.1 To be eligible to play in the Over 45 Women's Competition, a player must have turned 45 by the 31st of December of the previous calendar year with the following exemptions for under-age players.

- For season 2026, up to five (5) under-age players are permitted per team provided they have turned a minimum of 40 by 31 December of the previous calendar year.
- For the 2027 season, up to five (5) under-age players are permitted per team provided they have turned a minimum of 41 by the 31st of December of the previous calendar year.
- For season 2028, up to five (5) under-age players are permitted per team provided they had turned a minimum of 42 by 31st of December of the previous calendar year.
- For season 2029, up to five (5) under-age players are permitted per team provided they had turned 43 by the 31st of December in the previous calendar year.
- For season 2030, up to five (5) under-age players are permitted per team provided they had turned 44 by the 31st of December in the previous calendar year.
- For season 2031 and beyond, all players must have turned 45 by the 31st of December of the previous calendar year.

4.10 To be eligible to play in the Over 35 Men's Competition, a player must have turned 35 before the 31st of December of the previous Calendar Year.

4.11 To be eligible to play in the Over 45 Men's Competition, a player must have turned 45 before the 31st of December of the previous Calendar Year however, only in the O45 div 1 competition, a team is permitted to have up to three (3) under-age players who must have turned 43 by the 31st of December of the previous Calendar Year.

4.11.1 To be eligible to play in the Over 55 Men's Competition, a player must have turned 55 by the 31st of December of the previous calendar year with the following exemptions for under-age players.

- For season 2026, up to five (5) under-age players are permitted per team provided they have turned a minimum of 52 by 31 December of the previous calendar year. A maximum of Two (2) of these five (5) under-age players may be younger but must have turned 50 by 31 December of the previous calendar year.

- For the 2027 season, up to five (5) under-age players are permitted per team provided they have turned a minimum of 53 by the 31st of December of the previous calendar year. A maximum of Two (2) of these five (5) under-age players may be younger but must have turned 51 by 31 December of the previous calendar year.
  - For season 2028 up to five (5) under-age players are permitted per team provided they had turned a minimum of 54 by 31st of December of the previous calendar year. A maximum of Two (2) of these five (5) under-age players may be younger but must have turned 52 by 31 December of the previous calendar year.
  - For season 2029 up to two (2) under age players are permitted per team provided they had turned 53 by 31 December of the previous calendar year.
  - For season 2030, up to two (2) under age players are permitted per team provided they had turned 54 by 31 December of the previous calendar year.
  - For season 2031 and beyond all players must have turned 55 by the 31<sup>st</sup> of December of the previous calendar year.
- 4.12 Players registering for non-competitive football must have turned four (4) years old by, or on, the 31st December in the previous year.
- 4.13 It is the responsibility of the Club to ensure a player is eligible to play in his/her registered age group by obtaining documented proof of age. Any breach of this By-Law shall result in any game in which the player plays being deemed to be a forfeit.
- 4.13.1 Clubs entering teams in age group competitions must provide original birth certificates or satisfactory evidence of age of players if requested by the Association.
- 4.13.2 The Competitions Manager shall deduct competition points in respect of each game played by the player or players in question until evidence of age is provided. An aggrieved Club may seek a review from Hills Football of any such decision under this By-Law.
- 4.14 No player may be registered with more than one Club at any one time in any one competition season.
- 4.15 All females will be allowed to dual register within the same club into two age group/grades and pay only the one rego fee, whichever is higher. Females are permitted to play in mixed competitions should their club deem their ability suitable for that division/team.

- 4.16 Any registered player proved to have played in any competition match of Association Football outside the Association without the permission of Hills Football may be suspended for a period to be determined by the GPT.
- 4.17 No player may be registered with the Association after 4.00pm on 30th June, or the Friday preceding the 30th June if the 30th June falls on a weekend.
- 4.18 A player having been registered with the Association as a member of a Club may deregister from that Club and register with another Club upon the Club notifying the Association in writing that the player has been deregistered in Play Football.
- 4.19 Where a player deregisters from one Club and registers with another Club, the first Club will only be charged the appropriate amount of registration. The second Club will be charged the Association Fee, FNSW Fees & FFA Fees.
- 4.20 No registered player may deregister from one Club and register with another Club on more than one occasion in any one season.
- 4.21 Any player who seeks to deregister from one Club and register with another Club and is refused a clearance from his/her Club may appeal in writing to Hills Football for permission to register with another Club.
- 4.22 No player may be deregistered from one Club and registered with another Club, or from one team to another team within a Club, after the close of player registrations as in By-Law 4.17
- 4.23 If an affiliated Club has more than one registered team playing in the same grade and division, it shall not permit any player to interchange within these two teams unless the interchange is previously sanctioned by the Competition Committee.
- 4.24 Transfer of the registration of a player of a Club between teams in the same grade and division or in the same grade and a lower division may be sanctioned by the Competition Committee. The Competition Manager may upgrade a player on request from the Club. This process must occur before the cut-off as stipulated by By-Law 4.17.
- 4.25 There are no age or gender limitations for players registering for Walking Football.

## **5 CLUB STRIP, PLAYERS EQUIPMENT & SPONSORSHIP**

*This By-Law requires that all Clubs register their playing strip with the Association to ensure it complies with appropriate standards, for example sponsorship.*

- 5.1 Players in all matches must appear in Club uniform (comprising shirt, shorts and socks) and approved footwear and shin pads. Devices or materials used to hold shin pads in place shall be the same colour as the socks or as close as possible.

- 5.2 Approval for colour registration/alteration and changes to any part of a Club's strip must be submitted at the time of Club affiliation or reaffiliation for consideration by Hills Football. Requests for approval of new strip or changes to existing strip must be accompanied by full colour photographs of the front and rear of shirts, shorts and socks.
- 5.3 Clubs must seek permission from Hills Football before putting advertising/sponsorship on their playing strip. If approved, patches will only be allowed in accordance with the Australia Cup Playing Strip Guidelines as follows
- 5.3.1 A patch not exceeding 450 cm<sup>2</sup> (21cm x 21cm, or rectangular) shall be permitted on the front of shirts.
- 5.3.2 Up to two patches not exceeding 300cm<sup>2</sup> (15cm x 20cm) and a maximum height of 15cm on the rear of shirts (2cm below and or above shirt number). A patch displaying a player's name shall be counted as one of these patches on the rear of the shirts.
- 5.3.3 A patch not exceeding 100cm<sup>2</sup> (10cm x 10cm) shall be permitted on each sleeve of shirts.
- 5.3.4 A patch not exceeding 100cm<sup>2</sup> (10cm x 10cm) shall be permitted on the front and or rear-side of each leg of shorts.
- 5.3.5 Any Club not complying with this By-Law shall be subject to a fine as per By-Law 13.
- 5.3.6 Any Club non-compliant shall be required to modify sponsorship patches within fourteen (14) days of notification.
- 5.3.7 Clubs may apply to the association for allowances to the above sponsorship guidelines.
- 5.4 Where the colours of Clubs' strip are similar, Hills Football shall determine if a 'clash of strip' has occurred. The home team (as per fixture list) shall be the team to change when a designated clash of strip occurs, unless otherwise directed by Hills Football.
- 5.4.1 Bibs of a different colour to the Club's regular strip and of different colour to the opposition strip will be sufficient to satisfy a change of strip. Playing shirts must be worn underneath bibs with the correct numbers as per the team sheet.
- 5.4.2 When a goalkeeper shirt clashes with the opposition playing shirt it shall be the goal keeper's responsibility to wear an alternative shirt
- 5.5 The Association must ensure that the Referees Committee is issued with a list of colour clashes designated by the Hills Football.

## Competition By-Laws

- 5.6 For games where Hills Football has designated a colour clash, it will be the responsibility of the Manager or Coach of the away team to inform the referee prior to the commencement of the game if the home team is not wearing an alternate strip. The game will then continue as normal at the discretion of the referee.
- 5.7 When requested by Hills Football, a sample of each Club's current playing strip must be supplied to Hills Football for approval.
- 5.8 When undergarments are being worn by a player, the undergarment shall be the same colour as the shorts or jersey the undergarment is being worn under. Where a head covering is being worn, it shall be the same colour as the jersey or black.
- 5.9 Each players playing number must be positioned on the back of their jersey and be clearly identifiable.
- 5.10 Players are permitted to wear sports goggles, sports glasses or sports sunglasses as long as, in the opinion of the referee, they pose no danger to the player or other players. The Optometrists Association of Australia has stated that children involved in sport, requiring assisted vision, should wear protective eyewear such as sports goggles or sports glasses with soft or flexible frames fitted with a plastic or polycarbonate lens.
- 5.11 As per IFAB Laws of the Game – Law 4, a player must not use equipment or wear anything that is dangerous. The players must be inspected before the start of the match and substitutes before they enter the field of play. If a player is wearing or using unauthorised / dangerous equipment or jewellery, the referee must order the player to remove the item.
- 5.12 Other equipment – non dangerous protective equipment, for example headgear, facemasks and knee and arm protection made of soft, lightweight padded material is permitted, as are goalkeepers caps and sports spectacles.

## 6 GROUNDS

*This By-Law requires that all Clubs provide consistent and appropriate ground dressing for their assigned grounds and any other grounds to which any of its teams have been allocated home ground status.*

- 6.1 Clubs are responsible for the dressing of their own ground or grounds unless the Competition Manager has allocated a team from another club home team status at a particular ground, in which case the home team is responsible for the dressing/undressing of the ground if required.
- 6.2 As a minimum, dressing shall consist of 4 corner posts, 2 nets, post and rope barriers or painted lines (unless field is fenced) to both sidelines at a minimum of 1.5m from the sideline.

- 6.2.1 For matches where By-Law 8.2.3 applies (grades Under 12 and Under 13 Girls), that ground shall also have easily visible posts or cones placed at the 15m (U12) 25m (U13 Girls) mark out from each goal line, placed 1m outside each touch line.
- 6.3 Clubs must dress grounds at least thirty (30) minutes prior to the scheduled kick-off of the first game on that ground, and clubs must ensure all ground dressing is maintained until the completion of the last game on that ground that day.
  - 6.3.1 Where a ground has more than one playing field, each playing field may be treated separately for the purpose of By-Law 6.2.
  - 6.3.2 For competitive football format matches, a field shall have a technical area identified with lines or cones provided for players and officials only.

## 7 NON-COMPETITIVE FOOTBALL FORMAT (U6 TO U11)

*This By-Law defines how non-competitive small sided football (also known as MiniRoos & MiniTildas) is structured for each season. MiniRoos & MiniTildas football is to foster skills development of younger players and is for ages Under 6 to Under 11.*

- 7.1 Except where varied in these By-Laws, non-competitive football games shall be played in accordance with the Association's MiniRoos / MiniTildas Match Rules.
- 7.2 Games shall be played as follows:
  - 7.2.1 For Under 6s and Under 7s, 4 v 4 games shall be played in twenty (20) minute halves with a five (5) minute half time on a field approximately 30 x 20 metres with portable goals 2m x 1m and ball size 3.
  - 7.2.2 For Under 8s and Under 9s, 7 v 7 games shall be played in twenty (20) minute halves with a five (5) minute half time on a field approximately 50 x 35 metres with goals 3m x 2m and ball size 3.
  - 7.2.3 For Under 10s and Under 11s, 9 v 9 games shall be played in twenty-five (25) minute halves with a five (5) minute half time on a field approximately 70 x 45 metres with goals 5m x 2m and ball size 4.
- 7.3 Match results and "competition" style tables shall not be published by the Association or Clubs for MiniRoos and MiniTildas grades U11 and younger.
- 7.4 Managers, Coaches, Club Officials or Spectators may not take the field unless requested to do so by the Referee and then only in the case of injury.
- 7.5 All Under 6 through to Under 11 shall be differentiated in the fixture list by Socceroo player surnames for mixed competition and Matildas surnames for MiniTildas female competition.

- 7.6 No games will be scheduled on Good Friday, Easter Saturday or Sunday, nor ANZAC Day. Where ANZAC Day falls on a Friday, Saturday or Sunday there shall be no games scheduled for that day.
- 7.7 Matches washed out by rain or unplayable due to ground unavailability shall be replayed in accordance with the HFL Wet Weather Procedure detailed in Annexure 1 or for matters not covered by the HFL Wet Weather Procedure, at the discretion of the Competition Manager.
- 7.8 Teams forfeiting without prior notice to the Association / Club shall incur a forfeit fee as prescribed in the By-Law 13. Forfeits must be advised by the Club to the association by email, SMS or phone providing at least two (2) business days notice.
- 7.9 In all games, if the commencement of a game is delayed, a shorter period of time must be played in equal halves to ensure the game is completed five (5) minutes prior to the scheduled commencement of the next game.
- 7.10 No addition is to be made to the duration of either half of the game in the event of time being lost due to injury or any other occurrence that causes play to be suspended.
- 7.11 Unlimited player interchange is permissible at any stoppage in play during the game, subject to the authority of the referee.
- 7.12 The home club may allocate referees for specific grades of non-competitive football. If no referee is allocated an agreement is to be reached on who will referee the match. If there can be no agreement the game will be abandoned and will not be replayed. The club(s) of both teams may be required to provide a written explanation of why the game was not played.
- 7.13 For age groups Under 8 and above teams must complete team sheets as per By-Law 8.9.
- 7.14 Fines for non-competitive football shall be set in By-Law 13.
- 7.15 Players may only be borrowed into the same age group or a higher age group with the following caveats:
  - 7.15.1 No limitation to borrowed players.
  - 7.15.2 Players may only be borrowed up to two ages higher than their own age group – this is based on the players age not the age group they are playing in.
  - 7.15.3 As there are no divisions denominated, there is no restriction on the division a player can play in, however clubs are encouraged to not abuse this, and play players in teams of similar skill levels.
- 7.16 No jewellery is permitted to be worn.

- 7.17 Casts are not permitted to be worn.
- 7.18 The official offside rule does not generally apply in MiniRoos and MiniTildas games. Goals can be scored from an offside position. Referees may direct players standing in blatant offside positions to move into on side positions.
- 7.19 For ages U8 to U11, where players are purposely and blatantly playing offside whether directed to or not, the referee will have the authority to award a free kick against the team who's player is purposely and blatantly playing off side, at the sole discretion of the referee.
- 7.20 For ages U8 to U11, when a goalkeeper catches or traps a ball or the ball crosses the goal line for a goal kick, the attacking team must retreat back behind the exclusion zone. The attacking team shall not be permitted to attack until such time as the defending team takes their second touch of the ball allowing the goalkeeper or other player not to be under pressure and allow them to play out with two touches before the attacking team can attack.
- 7.21 For ages U8 to U11, field sizes must be in accordance with the HFL and FA recommended field sizes and have the exclusion zones clearly identified by line markings, marker cones or other similar clearly identifiable means so the players clearly understand where the exclusion zone is.
- 7.22 All U8, U9, U10 and U11 matches are to be played with the latest finish time being no later than 1:00pm and any matches that cannot be hosted by a club within this time limit will have an effected match moved to a neutral ground where there is space. All clubs are committed to hosting any small-sided matches that are moved to their ground to allow these younger age grades to be finished no later than 1:00pm.
- 7.23 Instructional Referees when refereeing age grades U8 to U11, have authority to issue a "Respect Card" to a player for dissent, offensive insulting abusive language/gestures or violent conduct. Should the Instructional Referee issue a "Respect Card", to a player, the coach or manager of the player shall immediately remove the player from the field for a cooling off period of two (2) minutes.

## 8 COMPETITIVE FOOTBALL FORMAT

*This By-Law defines how competitive football is structured and conducted for each season. It is intended that Clubs ensure matches can proceed even when registered members of a team may not be available by allowing players of an appropriate standard from other teams within the Club to play in the match. This section does not apply to MiniRoos and MiniTildas Football except where the MiniRoos and MiniTildas By-law 7 specifically references therein.*

### 8.1 GENERAL PROVISIONS

- 8.1.1 FNSW tournaments will receive priority over Association organised competitions. The Association competitions will receive priority during the season over Club organised events.
- 8.1.2 All matches of competition football shall be conducted under the FIFA Laws of the Game, except where specifically varied in these By-Laws.
- 8.1.3 No game will be scheduled on Good Friday, Easter Saturday or Sunday as well as ANZAC Day. Where ANZAC Day falls on a Friday, Saturday or Sunday there shall be no games scheduled for that day.
- 8.1.4 In the Premiership, competition points shall be accumulative and allotted as follows:

|                        |   |

| <b>Win</b>             | <b>3 points</b>   |
| <b>Draw</b>            | 1 point   |
| <b>Loss</b>            | 0 points  |
| <b>Bye</b>             | 3 points, treated as a game played and applies in the event of a washed out round |
| <b>Win by forfeit</b>  | 3 points, with result being given as three (3) goals to nil (0)                   |
| <b>Loss by forfeit</b> | 0 points, with result being given as nil (0) goals to three (3)                   |

- 8.1.5 After the completion of the Premiership, should there be two or more teams equal on points, their competition table position shall be decided by:
- 8.1.5.1 Greatest number of wins;
- 8.1.5.2 Greatest goal difference (i.e. goals against subtract from goals for);
- 8.1.5.3 If the number of points, wins and goal difference are the same, then the greatest number of goals scored for.
- 8.1.5.4 Determination made at the discretion of the Competitions Committee.
- 8.1.5.5 Where teams in an age grade have played a different number of rounds due to weather or regrading, the teams in this age grade shall be ranked using the Average Points Per Game.

- 8.1.6 After the completion of the Premiership Competition, the top four (4) teams on the table in competition shall play in a Championship Competition.
- 8.1.7 Any club wishing to defer a game must complete the following process:
  - 8.1.7.1 Download and complete the Reschedule Match Request Form at least five (5) days prior to the scheduled date of that game ([click here](#) to access form);
  - 8.1.7.2 Send the Reschedule Match Request Form to the opposing club with a proposed date, time and location of the rescheduled match;
  - 8.1.7.3 Once both clubs have agreed, the completed and signed Reschedule Match Request Form must be sent to the HFL Competitions Manager no later than 48 hours prior to the start of the original scheduled match date to ensure HFL can update the draws.
  - 8.1.7.4 Once both clubs agree, as well as HFL accepting the Reschedule Match Request Form, the rescheduling of the match is final and any further reschedule requests will not be considered by HFL.
  - 8.1.7.5 On request with at least 48 hours-notice an automatic deferment will be granted for any Association match/s scheduled during the same weekend for any team playing in any Football NSW tournament at either a regional centre or in the final.
- 8.1.8 Premiership Competition games washed out by rain or unplayable due to ground unavailability shall be replayed in accordance with the HFL Wet Weather Procedure detailed in Annexure 1 or for matters not covered by the HFL Wet Weather Procedure, at the discretion of the Competitions Manager. No application for deferred games shall be considered with the exception that a Rescheduled Match Request Form is completed.
- 8.1.9 In the Championship and the final series, in the event of any Round being washed out, that Round will be rescheduled prior to any subsequent round, until the washed-out Round is played or until the remainder of the Round is cancelled.
- 8.1.10 If the Championship Competition is affected by wet weather, the Championship Competition match affected by wet weather will be rescheduled at the discretion of the HFL Competitions Manager.

8.1.11 The size of the match ball in the various grades shall be:

8.1.12 The duration of matches in the various grades shall be 2 equal periods of –

| Grade                                 | Minutes per half   |

| Under 12                              | 25 minutes   |
| Under 13 to Under 14                  | 30 minutes   |
| Under 15 to Under 16                  | 35 minutes   |
| Under 18, U21 and All Age             | 45 minutes   |
| Over 30, Over 35, Over 45 and Over 55 | 40 minutes   |
| Super League and Premier League       | 45 minutes + stoppage time for Super League and Premier League First Grade |
| Walking Football                      | 20 minutes   |

8.1.13 In the event of any game not being played owing to weather or other causes over which neither Club has any control, a game is considered completed/played if a minimum of 50% of the game has been played. For the avoidance of doubt, if less than 50% of the allotted game time referenced in By-Law 8.1.12 has been played, the game will be required to be replayed.

8.1.14 Except where specifically varied in these By-Laws, no addition is to be made to the duration of either half of the game in the event of time being lost due to injury or any other occurrence that causes play to be suspended.

- 8.1.15 If the commencement of a match is delayed, a shorter period of time must be played in equal halves. However, for Super League and Premier League, no shortened times will be played.
- 8.1.16 Players taking the field of play in any game must have shirts with unduplicated numbers within their team, including any upgraded players. Shirt numbers for all players in each team shall correspond to the number appearing on the team sheet for that player.
- 8.1.17 No jewellery is permitted to be worn.
- 8.1.18 Casts are not permitted to be worn.
- 8.1.19 Over 30 and O45 Women Players may cross their arms over their chest during game play to protect their breasts from a ball strike. The arms must be flat against the chest and not moving to interfere with the balls natural expected movement, making the arms effectively the chest.
- 8.1.20 For U12's competitions, in alignment with the FNSW Junior Development League (JDL) competition format 9 v 9 games shall be played on a field set up and played, on a field size of between 60 – 70m in length and 50m – 60m wide with goals 5m x 2m.
- 8.1.21 For U13's Girls competition, in alignment with the FNSW Girls JDL competition format 10 v 10 games shall be played on a field set up and played, where possible 18 yard box to 18 yard box and 50m – 60m wide with goals 5m x 2m.

### **8.2 COMPETITION STRUCTURE (EXCLUDING MEN'S PREMIER LEAGUE)**

- 8.2.1 All competitive football shall consist of a Premiership Competition and Championship Competition, subject to By-Law 8.1.9 at the discretion of the Competition Manager.
- 8.2.2 For grades Under 12 and girls U13, corner kicks are to be taken 7 metres out from the penalty area
- 8.2.3 For competition grades playing on a smaller field being Under 12 and Under 13 Girls, at the taking of a goal kick, the attacking team shall remain at least 15 metres for U12 and 25 metres for U13 Girls from the defending team's goal line until: the goal kick is taken and is touched by a second player of the defending team; the ball travels beyond the 15m (U12) and 25m (U13 Girls) line; play is stopped for any other breach of the rules; or the ball goes out-of-play.

8.2.3.1 If an attacking player encroaches within the 15 metres (U12) 25 metres (U13 Girls) boundary in breach of the conditions of By-Law 8.2.3 then play shall be stopped and the goal kick retaken.

8.2.3.2 If an attacking team player repeatedly encroaches as per By-Law 8.2.3.1, that player shall be cautioned by the referee.

8.2.4 For "Over Age" grades slide tackles are not permitted. A slide tackle is defined as a tackle where a player slides in with his/her feet and there is the potential of contact with an opposition player. Any breach of this rule is punishable by an indirect free kick.

### 8.2.5 CHAMPIONSHIP COMPETITION (FINAL SERIES)

8.2.5.1 The Championship competition shall be a finals series competition structured as follows:

8.2.5.2 If rain causes the Championship Competition to be reduced the Competitions Manager will refer to Annexure 1 – Wet Weather Policy to determine how this series will proceed.

8.2.5.3 If in any game of the Championship Competition the score at the end of full time is drawn, then extra time each way will be played. If at the end of extra time the score is still drawn, then a penalty shoot-out will occur. The duration of extra time in the various grades shall be 2 equal periods of –

| Over 30, 35, 45 and 55        | 10 minutes |
| Walking Football              | 10 minutes |
| Super League & Premier League | 15 minutes |

### 8.3 COMPETITION STRUCTURE FOR MEN'S PREMIER LEAGUE

- 8.3.1 There will be a Premier League competition, both comprising of First Grade and Reserve Grade teams.
- 8.3.2 The Premier League Shield will be awarded to the Premier League squad with the highest combined points of First Grade and Reserve Grade. First grade wins will be worth 6 points, draws worth 2 points. Reserve grade wins will be worth 3 points, draws worth 1 point.
- 8.3.3 Premier League competitions shall consist of a Premiership Competition and Championship Competition.

#### 8.3.4 PREMIERSHIP COMPETITION

- 8.3.4.1 Ten (10) team competitions to form the basis of Premier League competitions.
- 8.3.4.2 10 Team Competitions: Will play eighteen (18) rounds, playing each opponent twice.
- 8.3.4.3 8 Team Competitions: Will play twenty-one (21) rounds playing each opponent at least three times.
- 8.3.4.4 Stoppage time will be played in all Premier League First Grade Premiership games.

#### 8.3.5 CHAMPIONSHIP COMPETITION

- 8.3.5.1 The Championship competition shall be a finals series competition structured as follows (for both First Grade and Reserve Grade):

8.3.5.2 If rain causes the Championship Competition to be reduced the Competitions Manager will decide how this series will proceed depending on time available.

8.3.5.3 If in any game of the Championship Competition the score at the end of full time is drawn, then fifteen (15) minutes each way will be played. If at the end of extra time the score is still drawn, then a penalty shoot-out will occur.

8.3.5.4 Stoppage time will be played in all Premier League Championship games at the discretion of the referee.

8.3.5.5 A Player is eligible to play in Reserve Grade Championship Competition matches under the following scenarios:

- If the club's First Grade team also make a Championship Competition match, being a semi-final, final or grand final, all registered PL squad players are eligible for the same corresponding round of a Reserve Grade Championship Competition match.
- If the club's First Grade team does NOT also make a Championship Competition Match, only the following players will be eligible for Reserve Grade.
  - a Players who have played at least 60% of their total games in Reserve Grade. This does include players who play both Reserve Grade and First Grade on the same match day.
  - b Should clubs be in a situation where they are short on numbers for finals, clubs may apply to Hills Football for dispensation.
  - c Should a player be affected by injury during the year, the club may apply to HFL for dispensation.

8.3.6 In the event of a Club being unable to provide sufficient players to take the field in both the reserve and first grade games and therefore wishing to forfeit one game, the Club can only forfeit the reserve grade game.

8.3.6.1 Should a Premier League squad forfeit two (2) or more games in a season due to insufficient available players, the Club must present a case to Hills Football for their inclusion in the Premier League Competitions for the following season. Hills Football will then

determine if the said Club be relegated to the Super League or All Age Competition for the following season.

### 8.4 COMPETITION STRUCTURE FOR WOMEN'S PREMIER LEAGUE

*The Women's Premier League Competition matches shall be played under the same rules as all other All Age Women's competitions (with the exception of the 'Championship' competition) but as a stand-alone competition with no promotion and relegation to other All Age Women's competitions.*

8.4.1 The Championship competition for the Women's Premier League shall be a finals series competition structured as follows:

8.4.1.1 In consultation with HFL Clubs, HFL may enter into a joint association Women's Premier League and or Under 21 division 1 Women and or O30 Division 1 Women competition with one or more other associations which will have competition By-laws or regulations for that competition separately defined as agreed with the other association/s.

### 8.5 SUBSTITUTION & INTERCHANGE

8.5.1 In "Over Age" grades unlimited player interchange is permissible at any time when there is stoppage of play during the game. No more than eighteen (18) players may participate in any match for any one team. More than eighteen (18) names appearing on a team sheet will constitute a fine against that team as per By-Law 13. Where the opposition Manager believes that a team has actually played more than eighteen (18) players, the manager shall inform the Referee who shall note this on the back of the team sheet. The team playing more than eighteen (18) players may be subject to a forfeit at the discretion of the Judiciary.

8.5.2 In Under 12 unlimited player interchange is permissible at any time when there is stoppage of play during the game. No more than fourteen (14)

players may participate in any match for any one team. More than fourteen (14) names appearing on a team sheet will constitute a fine against that team as per By-law 13. Where the opposition Manager believes that a team has played more than fourteen (14) players, the manager shall inform the Referee who shall note this on the team sheet. The team playing more than fourteen (14) players may be subject to a forfeit at the discretion of the Judiciary.

- 8.5.3 In grades Under 13 to Under 16 unlimited player interchange is permissible at any time when there is stoppage of play during the game. No more than sixteen (16) players may participate in any match for any one team. More than sixteen (16) names appearing on a team sheet will constitute fine against that team as per By-law 13. Where the opposition Manager believes that a team has played more than sixteen (16) players, the manager shall inform the Referee who shall note this on the team sheet. The team playing more than sixteen (16) players may be subject to a forfeit at the discretion of the Judiciary.
- 8.5.4 In grades Under 18, Under 21 and All Age, unlimited player interchange is permissible at any time when there is stoppage of play during the game. No more than eighteen (18) players may participate in any match for any one team. More than eighteen (18) names appearing on a team sheet will constitute a fine against that team as per By-Law 13. Where the opposition Manager believes that a team has actually played more than eighteen (18) players, the manager shall inform the Referee who shall note this on the back of the team sheet. The team playing more than eighteen (18) players may be subject to a forfeit at the discretion of the Judiciary.
- 8.5.5 In Premier League Reserve Grade unlimited player interchange is permissible at any time when there is stoppage of play during the game. No more than eighteen (18) players may participate in any match for any one team. More than eighteen (18) names appearing on a team sheet will constitute a fine against that team as per By-Law 13. Where the opposition Manager believes that a team has played more than eighteen (18) players, the manager shall inform the Referee who shall note this on the team sheet. The team playing more than eighteen (18) players may be subject to a forfeit at the discretion of the Judiciary. All players noted on the Reserve Grade team sheet for a match are deemed to have played in that match with clubs being reminded about the Championship Competition eligibility By-Law 8.3.5.5.
- 8.5.6 In Premier League First Grade the same By-Law 8.5.4 applies with the exception of an additional restriction to unlimited interchange. From the

80<sup>th</sup> minute mark, only one interchange per team is permitted after this time unless due to a legitimate injury. All players noted on the First Grade team sheet for a match are deemed to have played in that match with clubs being reminded about the Championship Competition eligibility By-Law 8.3.5.5.

- 8.5.7 In Super League the same By-Law 8.5.4 applies with the exception of an additional restriction to unlimited interchange. From the 80<sup>th</sup> minute mark, only one interchange per team is permitted after this time unless due to a legitimate injury.

### **8.6 PLAYER IDENTITY CARDS**

- 8.6.1 All competitions are played under the Photo ID system.
- 8.6.2 Each team manager shall present the Electronic Team sheet to the opposition manager to check prior to the commencement of the game. The opposition manager has the right to sight any or all the players for verification against the Photo ID photograph. If the opposition manager contests the identity of a player, the manager should note on the team sheet that they contest the identity of the player, noting the name and ID of the player from the team sheet.
- 8.6.2.1 If Photo IDs are not available for inspection prior to the start of the match, the game shall be forfeited by the offending team. The opposition manager must advise the referee of the situation and the non-offending team will mark the Team sheet as disputed and mark on the team sheet the reasons for the dispute.
- 8.6.3 No protests will be accepted regarding player eligibility and identity if Photo IDs are not checked prior to the start of the game.
- 8.6.4 Should a Photo ID not be available for an individual player, then said player shall not be eligible to take the field in any game.
- 8.6.5 Photo IDs for players, substitutes and interchange players that arrive after the opposition manager has sighted the team Photo IDs, must be produced to the opposing manager before the player, substitute/interchange player takes the field of play.
- 8.6.6 A manager has the right, at any time during the game, to request from the opposition manager the Photo IDs for that particular team if he/she has any doubt about the eligibility of any player on the field.

### 8.7 PLAYING OUT OF GRADE/BORROWING

- 8.7.1 During the premiership competition a player is entitled to play out of grade subject to the general provisions and applicable age specific provisions.
- 8.7.2 A team is only allowed to borrow a maximum of four (4) players within any premiership fixture (except for men's premier league).
- 8.7.3 During the Championship competition there will be no borrowing of players.
- 8.7.4 Borrowing will be as per the borrowing matrix located at Annexure 2

#### 8.7.5 MEN'S PREMIER LEAGUE

- 8.7.5.1 Players registered to play in Premier League are ineligible to play in any other competition.
- 8.7.5.2 Premier League may borrow players from any division from any grade, provided at all times the player is over the age of 16.
- 8.7.5.3 Premier League can borrow up to a maximum of 9 players in any one fixture from other grades. A minimum of 7 registered Premier League players must be on the field at all times.
- 8.7.5.4 Premier League players may be freely transferred between first grade and reserve grade throughout the premiership. Clubs must ensure they are aware of by law 8.3.5.5 in regards to finals qualification of players.

### 8.8 FORFEITS

- 8.8.1 Matches shall be played on the ground/Field allocated by the Association and shall commence at the official kick-off times. For the avoidance of doubt, clubs shall not be permitted to change the ground/field allocated by the Association where games are to be played. Any team failing to play its match as set down shall be deemed to have forfeited the match. Where a club is aware that a team will forfeit, the club must notify the Office of the Association of the forfeit no later than two (2) business days immediately preceding the game.
- 8.8.2 In all grades, if a team is unable to field at least seven (7) of its registered players at the scheduled starting time, then such team will be deemed to have forfeited the match. No grace period shall be permitted.
- 8.8.3 Where a team loses enough players in a match that are unable to return to the field due to injury, send-off etc, such that it can no longer field seven (7) of its own registered players then the game shall be forfeited by the team

who cannot field seven (7) registered players, and the referee must record the fact on the back of the Team Sheet..

- 8.8.4 Teams forfeiting on two (2) consecutive occasions per season will automatically be referred to the General Purposed Tribunal.
- 8.8.5 Any team that forfeits a match shall be fined in accordance with By-Law 13. A forfeit fee will not apply where two (2) business days advance notice is given to the Association.
- 8.8.6 Any team which plays an ineligible player, suspended player, or a player who is not registered with the Association shall be deemed to have forfeited that match.
- 8.8.7 Where a team forfeits a match, such match shall be treated as a game by the opposing team for all purposes of these By-Laws and Schedules.
- 8.8.8 **Football NSW Tournament:** Where a club which has agreed to represent the Association in a Football NSW Tournament and forfeit's a FNSW Tournament match, the Club will be charged any amount imposed by FNSW in respect of the forfeit.

### 8.9 TEAM SHEETS

- 8.9.1 In all competition matches, Hills Football will use electronic team sheets.
- 8.9.2 All information contained on Team Sheets will be deemed as correct once it has been signed by the Team Managers from both clubs. Unless an Official Letter from both Clubs is received by HFL within 48 hours of the finish of the match, the results of the match is final and cannot be appealed to HFL.
- 8.9.3 The home team will provide paper team sheets in the event that the electronic team sheets are not available for any reason. The paper team sheets are to be completed in accordance with the instructions of the Competition Committee. All paper team sheets are to be delivered to the HFL office by 10am the following Monday. Scores must be entered by both clubs via the Association's electronic competition software, Dribl.

### 8.10 REFEREES

- 8.10.1 Where no official referee is available, it shall be the duty of the two team managers to reach a decision and appoint a substitute referee. If there can be no agreement the game will be abandoned and may be replayed at the discretion of the Competition Manager. The club(s) of both teams may be required to provide a written explanation of why the game was not played.
- 8.10.2 The person or persons who referee the match have the same authority and rights as an official referee, including, but not limited to, cautioning or

sending off a player and submitting incident reports. The person or persons who referee the match should sign the electronic team sheet, noting any cautioned players, players sent from the field or incidents as appropriate.

- 8.10.3 Where an active, qualified member of the Referees Association is present at the ground, that referee has the right to referee the match, providing that the match is at the level of game the Referees Association member normally covers.

## 9 DISCIPLINE

*This By-Law defines how grievance or disciplinary matters are dealt with.*

- 9.1 All aspects of grievance and disciplinary matters are set out in the Association Grievance and Disciplinary Regulations attached as a Schedule to these By-Laws. The Schedule is to be read in conjunction with these By-Laws and the Association Constitution.

## 10 PROTESTS/APPEALS

*This By-Law defines how Clubs or players may appeal decisions of the Association or constituted bodies of the Association.*

- 10.1 All appeals or protests will be conducted in accordance with the Association Grievance and Disciplinary Regulations set out in the Schedule to these By-Laws. The Schedule is to be read in conjunction with these By-Laws and the Association Constitution.
- 10.2 All appeals will be heard under the Association Appeals Procedures as drawn up by the Association. A copy of these procedures shall be provided to all appellants.

## 11 PERPETUAL TROPHIES

*This By-Law defines the management of perpetual trophies*

- 11.1 Clubs shall return to the Association, by 30th June in each year, any perpetual trophies presented to their teams for the previous season. Clubs failing to return same by the said date will incur a fee per trophy as prescribed in By-Law 13. Replacement for or repairs to trophies will be incur a cost to the club responsible.

## 12 SPECIAL COMPETITIONS

*This By-Law allows the Associations to run competitions other than those described elsewhere in these By-Laws.*

- 12.1 The Association may conduct special competitions under such rules and conditions as directed by Hills Football.

- There may be an O35 Friday Night competition, with two divisions of six teams each competing in both a Premiership & Championship Competition.
- Divisions to be known as; O35 Friday 1 & O35 Friday 2.
- Premiership Competition.
- 6 Team Competitions to form the basis of O35 Friday Night competition
- 6 Team competitions: Will play fifteen (15) rounds, playing each opponent three (3) times.
- After rounds five (5) and ten (10) have been played, there will be a whole competition bye.
- Premiership Competition winner will be determined by the team on top of the competition ladder after 15 rounds.
- The Championship competition shall be a finals series competition structured as follows (for both divisions);

### 12.3 WALKING FOOTBALL

All clubs shall promote the competition being played on Sundays and to have all clubs open this age grade in their registration system and where a club has some players registered but not enough to field a full team, the relevant club are to put these players in touch with a person designated by Hills Football who will champion this competition for the Association. This person will be advised to clubs at the beginning of each year for each upcoming season.

The Association will be conducting Walking Football offering a social, small-sided and sustainable version of football specifically modified for older Australians. Clubs will be able to enter teams into this competition which will be played on Sundays between the hours of 11:00am to 1:00pm in a hub.

The competition focusses on passing rather than speed / running; flexible with its formats and accessible to the community and prospective players. There are no age or gender restrictions for walking football. The competition will highlight the health, well-being and social benefits of regular football and exercise activities for older people.

#### **Format**

It is low impact, team based exercise, utilising the defined Walking Football Rules and Formats specifically non-contact with the players always having one foot on the ground at all times.

Matches are played with modified formats (5v5/6v6) on a smaller field approximately 50m x 35m with goals 5m x 2m and ball size 5.

The competition aims to provide participants physical and mental health benefits, social contentedness and promotion of the benefits of ongoing physical activity.

#### **Structure**

- Running is not allowed.
- A participant always has to have one foot on the ground at all times.
- It is a non-contact version of the traditional game.
- The ball cannot be kicked above head height.
- There is no heading of the ball.
- There are no referees as such and the competitive angle is kept to a minimum.
- The focus is on fun and making friends.

## 13 FEES AND FINES

*This By-Law defines the fees and fines that may be applied to Clubs, teams or players in accordance with general By-Laws.*

13.1.1 In addition to the above fees, if notification of such forfeit is NOT given to the Association no later than one (1) business day immediately preceding the game, then the team forfeit fee shall be double the appropriate fee. In addition to the above fees, if notification of such a forfeit is not given to the Association by 4:00pm on the Friday preceding the game then the team forfeit fee shall be double the appropriate fee.

13.2 **Protest Fee:** \$200.00

13.3 **Appeal Fee:** \$250.00 (\$100 of which is not refundable)

13.4 **Late Team Registration Fine:** \$100.00

### 13.5 Team Sheet related fines, including:

- No, late or incorrect result submitted
- More than the allowed players on team sheet
- Non completion of team sheet (prior and post match)
  - First Offence = Written Warning
  - Second Offence = \$10 fine
  - Third Offence = 1 point deduction from team
  - Fourth Offence = 3 point deduction from team
  - Fifth Offence = Potential removal from competition

13.8.2 Forfeit Fee - \$250 (or such other amount as FNSW may impose)

13.9 Fines for non-competitive football shall be \$5.00 per infringement except where varied by By-Law 13.1.

13.10 Fine for not complying with Strip & Sponsorship (see By-Law 5.3.1) shall not exceed \$500.

### ANNEXURE 1 – HFL WET WEATHER PROCEDURE

Following are the procedures adopted by the Association and Clubs when grounds are affected by prolonged or heavy rain and the responsibilities of the Association, Clubs and referees for rain on match days.

#### HILLS SHIRE COUNCIL

As the owner and / or manager of all Hills Shire public grounds allocated to the Association / Clubs, including school grounds, the Hills Shire Council has the overarching decision regarding the suitability of grounds for matches and training. Council usually makes decisions regarding the availability of grounds following heavy wet weather for weekdays and weeknights and will generally allow the Association / Clubs to make decisions for playing competitions on Friday evenings and weekends.

Generally, only under severe weather conditions will Council enforce weekend closures. Council's Wet Weather Updates for Sporting Fields Information can be obtained via phone (02) 9843 0354 or via the internet <https://www.thehills.nsw.gov.au/Venues/Find-a-Sportsfield/Sportsfield-Wet-Weather-Update> Information is generally updated regularly and usually includes the date of inspection, period of closure (if any) and the date of the next inspection.

Clubs should encourage all Coaches and Managers, and inform parents and players, to use the Wet Weather Updates for Sporting Fields Information sources if in any doubt regarding ground availability for training and games. Council may permit weeknight competitions such as Touch Football, Oz-Tag or other sports to proceed on specific grounds and also allow important school daytime matches even if the grounds are closed.

When grounds are CLOSED, training is NOT PERMITTED for any code or activity. Never assume that competition matches are cancelled if fields are closed on Friday's. Always wait for official advice from the Association. Note: Clubs and teams training during the week when grounds are closed face possible punishment imposed by Hills Shire Council, including costs of repairs and penalties imposed by the Association.

#### HILLS FOOTBALL LIMITED & CLUBS

The following situations require the Association to make decisions on the previous day or early on match days regarding the condition of grounds following rain and their suitability to conduct competition matches:

1. Grounds have been closed by Council for parts of Monday to Friday, but the Association / Clubs are permitted to make a decision for Friday night and weekend matches.
2. Grounds have been closed by council up to and including Friday night, but the Association / Clubs are permitted to make a decision for weekend matches.
3. Heavy rain on Friday night and or during the weekend.

For the above three situations, Club Ground Inspection Officers will be requested to inspect their home grounds and report on the condition of the grounds no later than 4:30pm on Friday evening match days for situation 1 and 7:00am on Saturday and Sunday match days for situations 2 and 3 by SMS text to phone number provided by HFL office prior to the commencement of the season.

Whilst Clubs have authority to close their grounds when affected by wet weather, Clubs are required to contact the HFL Competitions Manager to discuss any field closure prior to making that decision known publicly and or notifying on social media. The HFL Competitions Manager will be on duty to receive the calls / reports from 3:00pm for Friday Night Competition Matches and from 6.30 am for both Saturday and Sunday Competition Matches. Please phone the Competitions Manager.

After all reports are received, a decision will be made as follows, either:

1. All games are to be played; or
2. All games called OFF with a decision regarding the re-drawing of these games to be made by the Competitions Committee at a later date; or
3. Some grounds declared playable with games drawn at unplayable grounds either relocated to other grounds where possible on the same day or postponed to a later date. Following the decision, Club Wet Weather Contact Officers will be advised by SMS text and/or email, and Dribl and social media will be updated accordingly.

Note: It is not always possible to inform Clubs of the decision in time for early games. e. g. 8.30 am kick offs. Clubs and teams are reminded, WHEN IN DOUBT GO TO THE GROUND FOR KICK OFF TIME or risk loss by forfeit.

Prior to the season all Clubs are required to advise the Association of the names and contact telephone numbers of their:

Ground Inspection Officer

Alternate Ground Inspection Officer

Wet Weather Contact Officer

This information is required to allow the Association to request Clubs to carry out inspections or to seek additional information re the ground condition after the inspection.

### REFEREES

Referees have the right to declare a ground unplayable and decide that a match will not be played. They can only rule on matches they have been appointed to, and their decision can only be made at either kick-off time for the match or during a match should the field become unsafe or unplayable. Referees cannot rule all games off for the day.

### CLUBS AND GROUND CONTROL

For rain developing during the day, a Club may rule that no further play is possible on the ground. This decision must be confirmed by a telephone call to the HFL Competitions Manager and then, if possible, contact the Clubs of visiting teams drawn to play on the ground later in the day.

Clubs shall not display on their SOCIAL MEDIA platforms that their 'GROUND IS CLOSED' without consultation with the HFL Competitions Manager or their nominee.

### AFFECT ON MATCHES

Annexure 1 HFL Wet Weather Procedure is in place for all winter football conducted by HFL and may be updated for each season based on field allocation dates, Easter and Anzac Day public holidays and other field access requirements.

1. Up to and including Round 15 of Competitions, all matches that can be played on available fields shall be played and any washed out matches shall be rescheduled (makeup game) within three weeks where possible.
2. From Round 16 of Competitions onwards, only when more than 60% of fields are declared unplayable via this procedure prior to commencement of a match day, no matches are to commence, and a decision will be made by HFL whether to cancel or replay the entire round.
3. Once a match day has commenced and the first games have kicked off, all matches that can be played on available fields for the match day round shall be played.
4. Should wet weather and the closure of fields cause an age grade to have played a different number of rounds when teams need to be ranked for the Championship Competition, team rankings shall be based on the Averages points system within Dribl.
5. Should any matches be washed out during rounds 16 and 17, HFL shall determine whether there is sufficient time to replay these matches considering the weather forecast and state of the fields and shall use the Averages points system in the event of item 4, effect on Matches.
6. Should any matches be washed out in round 18, these matches shall not be replayed and HFL shall use the Averages points system in the event of item 4, effect on Matches.
7. Priority shall be given to maintaining a three-week conventional Championship Competition series over premierships rounds.
8. Should week 1 of the Championship series be washed out in accordance with item 2, week 1 shall not be replayed and the Championship series shall be adjusted to a two-week Championship series with week 2 having matchups of 1 v 4 and 2 v 3 with the winners progressing to the Grand Final in week 3.
9. Where week 1 of the Championship series has been played and week 2 is washed out in accordance with item 2, week 2 shall not be replayed and the Championship series shall be

adjusted to a two-week Championship series with the winners of week 1 semi-final 1 and semi-final 2 progressing to the Grand Final in week 3.

10. Where week 1 and 2 have been played but week 3 is washed out in accordance with item 2, week 3 shall be replayed the following week. Should the following week also be washed out in accordance with item 2, Hills Football shall promptly determine whether other fields may be hired to allow Grand Finals matches to be played as a priority, noting if fields are available Grand Finals will need to be played when fields are available which may be mid-week evenings or a Saturday or Sunday with all efforts being made to play the Grand Finals. Where fields are not available within a reasonable timeframe as determined by the Competitions Manager, the Grand Finals shall not be played and there shall be no champions awarded.
11. During the Championship series, should partial matches be washed out, these washed out matches shall be replayed within five days on available fields which may be fields hired by HFL to have these matches played. Should a team not agree to play a match within five days of a wash out, that team shall forfeit the match.
12. All other matters relating to wet weather and/or field closures will be at the discretion of HFL.

### ANNEXURE 2 – AGE GRADES AND BORROWING MATRIX

Age grades for mixed / male and female competitions are listed below and on the annexure 2 matrix inclusive of player borrowing eligibility.

#### 1 GRADES

##### a Under Age Grades including open Age Grades (Mixed & Mixed MiniRoos)

**Lower Grade >>>>** U6 to U11 - U12 to U16, U18, U21, All Age, Super League, Premier League >>>> **Higher Grade**

##### b Under Age Grades including open Age Grades (Female & MiniTildas)

**Lower Grade >>>>** U8 to U12 – U13, U15, U16, U18, U21, All Age, Premier League >>>> **Higher Grade**

##### c Over Age Grades including Open Age Grades (Males)

**Lower Age Grade >>>>** O55, O45, O35, All Age, Super League, Premier League >>>> **Higher Grade**

##### d Over Age Grades including Open Age Grades (Females)

**Lower Age Grade >>>>** O45, O30, All Age, Premier League >>>> **Higher Grade**

#### 2. PLAYER BORROWING

##### General Principles

##### a Need to Borrow

The need for a team to borrow a player or players is only permitted when a team is impacted by one or more of their regular registered players being unable to play a match due to injury, illness or other absence. Borrowing is strictly prohibited to strengthen a team for the purposes of trying to obtain an advantage and or trying to win a match.

Where a team is impacted by player absences, a team is permitted to borrow up to a maximum of four (4) players from other grades in accordance with these By-Laws however a team that has one or more borrowed players is not permitted to have more players on the team sheet and playing than the amount of players registered for the season in that team, apart from Men's Premier League.

If the Competitions Committee determines the borrowing of players in a match was not in accordance with the Need to Borrow General Principles and in the spirit of fair play, the Competitions Manager will refer the matter to the Disciplinary Committee who may order the match to be replayed without borrowed players or deem the match to be a forfeit by the offending team.

### b Number of Borrowed Players

There is no limit to the amount of borrowed players in the non-competitive age groups from U6 to U11. For competitive teams whilst competing in the Premiership Competition, the maximum number of borrowed players in any team is four (4).

### c Duty of Care

Clubs and their Team Officials must exercise a duty of care to ensure players are not playing beyond their physical capability. In particular, special care needs to be taken when youth players are playing two years beyond their normal Age Group or in Open Division if they have turned 16 years of age.

### d First and Reserve Grade

Where an Age Grade is played as first and reserve grade, both teams are regarded as having the same division for the purposes of these Borrowing Rules. For the purpose of matches played for a team the first grade and reserve grade shall be considered separate teams.

### e Teams in Grades with Players Required to be Under a certain Age

- i. In all borrowing for teams required to have players under a certain age, Options A, B and C shall be followed in that order wherever possible.
- ii. Where a club has no eligible team in either Option A, B or C, a borrowed player may come from a team registered in the HFL Age Group in which the club has a team. In this case, the club must satisfy itself and pay particular attention to clause 2 c) Duty of Care.
- iii. In U12 to U21 age groups, the permitted division of the borrowed player's team is further restricted relative to the division of the Borrowing team as per below.

- f Teams in U18 Girls and U21 Mixed competitions can borrow players from the following competitions, provided they are under the relevant age on the 31st December of the previous year which would have allowed them to play in the U18 Girls or U21 mixed competition:

### g All Age Teams

- Teams in All Age Men divisions 3, 4 and 5 may borrow players registered in teams in the same open competition provided they are registered in a lower Division than the borrowing team. Teams in All Age Men divisions 6 and lower may borrow players registered in the same open competition and be borrowed up or down in divisions 6 and below.
- Teams in All Age Men's competitions may borrow players registered in Over 35 and Over 45 competitions.
- Teams in All Age Men's competitions may borrow players registered in Over 55 competitions.
- Teams in All Age Men divisions 3, 4 and 5 may borrow from U21 of one division higher or the same or lower division as the borrowing team. Teams in AAM divisions 6 and lower may borrow from U21 from either of the two lowest U21 divisions.

- v. Teams in All Age Men's competitions may borrow from U16 and U18 of any division provided the player has already turned 16 years of age.
- vi. Teams in All Age Women's competitions may borrow players registered in Over 30W and O45W Women's competitions.
- vii. Teams in All Age Women's may borrow from U18 Girls provided the player has already turned 16 years of age.
- viii. All Age Men's teams from the same club and same division competing in the same age grade are not permitted to borrow from each other.
- ix. Teams in Super League may borrow players from any team apart from Premier League provided the player is age eligible.

### **h Over 30, Over 35, O45 and O55**

- i. Borrowed players playing in Over 30, Over 35, Over 45 and Over 55 competitions must be age qualified to play in these competitions.
- ii. Teams in Over 30, Over 35, Over 45 or O55 competitions may not borrow players registered in the Super League or Premier League Competitions.
- iii. Teams in Over 30W div 1 competitions may borrow players in other Over 30W competitions provided players are registered in a lower division than the borrowing team.
- iv. Teams in Over 30W div 2 and lower competitions may be borrowed up or down in another O30W competition.
- v. Teams in Over 30W competitions may borrow players from O45 competitions and All Age competitions provided the borrowed player is age qualified.
- vi. Teams in Over 35 div 1 & 2 competitions may borrow players in other Over 35 competitions provided players are registered in the same or a lower division than the borrowing team.
- vii. Teams in Over 35 div 3 and lower competitions can be borrowed up or down in another O35 competition.
- viii. Teams in Over 35 competitions may borrow players from All Age competitions provided the players are registered in the same or a lower division than the borrowing team and the player is age qualified.
- ix. Teams in O35 division 1 Saturday competition may borrow players from Teams in the O35 division 1 Friday night competition, and teams in O35 division 2 and lower Saturday competition may borrow from the O35 division 2 Friday night competition.

- x. Teams in Over 35 competitions may borrow players from Over 45 or Over 55 competitions.
- xi. Teams in Over 45M div 1 competitions may borrow players from All Age competitions provided the players are registered in the same or a lower division as the borrowing team and the player is age qualified.
- xii. Teams in Over 45M competitions may borrow players from Over 35M competitions provided players are registered in the same or a lower division as the borrowing team and the player is age qualified.
- xiii. Teams in Over 45 div 2 and lower competitions as well as Over 55 players may be borrowed up or down in another O45 competition.
- xiv. Teams in O45W competitions may borrow players from AAW and Over 30W competitions provided the borrowed player is age qualified.
- xv. Teams in O55M competitions may borrow players from O35M and O45M competitions provided the borrowed player is age qualified.
- xvi. Over Age Men's teams from the same club and same division competing in the same age grade are not permitted to borrow from each other.
